Department Reports:

Supt. of Public Works Report – Maintenance Supervisor Timm reviewed his report. He stated they ran the press and hauled dirt from 407 to RR bed for use later. Hauled Vegetation out from 407 to RR bed and covered. They also cut trees on RR bed and pushed junk dirt off at RR bed from Birch Street expansion project. They continued brush pickup and took the batting cage net down at Warnken.
